

## CFHR's 2011 Ally Award goes to Chinese American Lee Mun Wah

The CFHR awarded Lee Mun Wah, an internationally renowned Chinese American documentary filmmaker, author, poet, Asian folk teller, educator, community therapist, and master diversity trainer. He was chosen as the 2011 Ally Award recipient because of his work and contribution to dialogue on race and the elimination of racial discrimination.

Mr. Wah is the Executive Director of Stirfry Seminars & Consulting and producer of the award winning documentaries such as "The Color of Fear," "Stolen Ground" and "Last Chance for Eden." Cherry Steinwender, who is the Founder and Co-Executive Director of The Center for the Healing of Racism, authored a book, "Bread is a Simple Food, Teaching Children about Cultures," which featured Sylvia Mayer's children, Zoe and Zach. This book was written to help children internalize the oneness of the human family and learn profound lessons about cultures with a simple tool--bread. The EMCEE was three-time Emmy winner, Ernie Manouse, from ErnieOnTV, whose charm, talent and humor made the event entertaining.
